If the Underlying never trades above the Barrier Level the investor receives 97% of the Nominal and participates in the positive Underlying performance up to the Barrier Level. If the Underlying ever trades at or above the Barrier Level, the investor receives at Redemption 97% of the Nominal plus the Rebate. The minimum repayment at maturity will be the Capital Protection.
