Redemption

The sum of all fractional entitlements to the Underlying, per Nominal, will be paid in cash, based on the Expiration Value. The coupon payment is due in any case.

Product Structure

The Kick-In GOAL with Early Redemption Feature is a product that provides a fixed coupon and the redemption is linked to the performance of the Underlying.

As long as no Early Redemption Event has occurred and the Expiration Value is above the Kick-In Level the Investor will receive 100% of the Nominal in cash. Otherwise, the Investor will receive the Underlying.

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from gains above the Kick-In level and for taking the risk of a loss potential equivalent to a direct investment in the Underlying.

In addition to a standard Kick-In GOAL, this Kick-In GOAL contains an early redemption feature: If the closing price of the Underlying is on any Observation Date at or above the Early Redemption Level, this Kick-In GOAL will early redeem at 100% of the Nominal in cash.
