The Open End Turbo Put Warrant moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency down and vice versa taking into account the conversion ratio and the adjustments of the Strike / Knock-Out Barrier. If the value of the Underlying at any time during the product life time lies at or above the Current Knock-Out Barrier, the Open End Turbo Put Warrant expires immediately and worthless.
