### **Product Structure**

The Lock-In Capped PERLES Plus is a product that provides participation in the performance of the Underlying up to a pre-defined Cap Level. This means that the Investor will receive a redemption value which reflects the performance of the Underlying up to the Cap Level, whereby this redemption value will not be lower than the Strike Level, as long as the Underlying never touches or breaches the Kick-Out Level during the life of the product. However, if a Kick-Out Event has occurred, Investors may fully participate in any negative performance of the Underlying and may lose some or all of their investment.

Additionally, the product is set up with a Lock-In feature, which provides a downside protection as soon as the Lock-In Level has been reached on the respective Observation Dates.
