The Speeder Plus is a product which tracks the performance of the Underlying with the possibility to leverage the performance in a given range while limiting the upside.

Furthermore the redemption value will not be lower than the Strike Level, if the Underlying does not close below the Kick-Out Level on the Expiration Date.
