The Lock-In Kick-In Goal is a product that provides a fixed coupon and an attractive return if at any Observation Date all Underlyings close at or above a predefined Lock-In Level. In this case the Investor will receive on the Redemption Date the Nominal.

As long as all Underlyings are at or above the relevant Kick-In Level at Expiry, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive

- 100% of the Nominal in cash, if at Expiry all Underlyings close at or above the respective Initial Underlying Level; or
- a value reflecting the performance of the worst performing Underlying, if at Expiry one or more Underlyings close below the Initial Underlying Level and no Lock-In Event has occurred.
